Starting in July, monthly resources concerning financial literacy will be made available to our members and will run until April 2018. Each month will focus on a certain topic, beginning with Paying for College in July. EXHIBIT A- Committee Reports

Awards Committee Report (Chair: Eduardo Martinez)

The committee met on Friday, June 10, 2017 at 9:30 pm. The committee spoke about some important concerns and goals that they wish to accomplish throughout the 2017-2018 service year. They would like to see a designated tab for Awards and Contests on the Florida Key Club Website, so that it can be easily seen and accessed by site visitors. The committee suggested that on the Awards applications, the name of the school should be selected from a "drop-down" menu to ensure the name will be the same used in the District Directory and by Key Club International. The committee will complete updating of the applications and entry by the August Board Meeting. Our first teleconference is scheduled for June 13, 2017. The members in the committee are excited to be working together and look forward to assisting Governor Felanté in the implementation of the directives for the committee. Online Pride Reports from the beginning of the service year through February 2018 are due Monday, March 5, 2017. Also, Wednesday, March 7, 2018 will be the deadline submission for pre-DCON Awards. The committee will be judging these awards on March 10, 2018.

<u>District Educational & Leadership Conference (DCON) Committee Report (Chair: Rebecca Yap)</u>

Before August Board the DCON Planning Committee will be revising past documents and identify ways to improve DCON processes. Through these improvements the Project Plan will be updated and sent to all members of the District Board; committees and subcommittees will complete the tasks listed on the Project Plan respectively. We will also be creating the DCON 2018 theme with prospective logos which will be revealed during committee presentations at August Board. The committee will be identifying 3-4 prominent themes and then generate a Google Form to be sent to the district for a vote and collect opinions. The fundraising guide will be updated, completed and published. The registration deadlines will be set and the dress code will be finalized.

Education Committee Report (Chair: Gabe Layne)

Before August Board Meeting, my committee and I plan to review all previously made educational PowerPoints used for KCKC, SZR, and DCON, and take note of all flaws that need to be improved in them. We will also be creating a universal PowerPoint template to use for all presentations that remain under Key Club standards. Finally, after a June/July conference call, we will edit all KCKC-related presentations to be finalized for August Board Meeting. In addition to PowerPoint work, the Education Committee has decided to create educational review games using Quizlet Live that will follow up important PowerPoint presentations. The Quizlet Live reviews will be created for the "Kiwanis Family Relations," "Club Officers," and "Awards and Contests" presentations. More information on what information the games will entail is to be decided. Our first conference call date and time was decided during this time. We also set deadlines for the PowerPoint review to be completed. As the presentations are reviewed and

discussed upon during conference calls, they will begin to be worked on. A universal design will be decided by July 20 and the committee will work to reformat the revised PowerPoints.

Endowment Committee Report (Chair: Robby Witten)

The Endowment Committee met for the first time this 2017-2018 year on June 9, 2017. We discussed the corpus, which is approximately \$400,000. One of our goals for the August Board Meeting is to create a timeline of goals and due dates, which we decided to discuss at our July meeting. This will be ready well before the August Board Meeting. The purpose of this committee is twofold. We would not only like to raise money for the Endowment to enable us to give out more scholarships at DCON, but also to lower the individual cost of DCON. This year, we will continue to focus on reaching our goal of raising \$1,000,000 over the span of the next three years. We discussed our goal of raising \$75,000 this year, and we brainstormed ideas to grow the endowment even further. We discussed ideas on how to increase awareness of the endowment and what it does for the members of Florida District of Key Club International Inc. The whole point of the endowment is give back to you, as Key Clubbers. At our conference call in July, we will discuss updating the promotional materials for KCKC. Committee members have been tasked with brainstorming ideas for corporate sponsorships that could be placed on the back of our DCON T-shirts, to be presented at our July board meeting call. Our focus this year will be expanding awareness of the endowment to families and parents of Key Clubbers. This will essentially allow us to try and get small donations from each family to grow the endowment. This concludes the report.

Governor's Project Committee Report (Chair: Jenna Coleman)

Before August Board, my committee and I plan to advertise and create a Governor's Project Handbook and send an email out to all club presidents as well as advisors to inform clubs about the newly published guidebook after it has been completed. There will be a set timeline of due dates and goals that leads up to District Conference. We will work in conjunction with the Scholarship Committee to update the Governor's Project scholarship. In addition, we will work with the Education Committee to form a HEALTH project presentation for KCKC. A hashtag will be created to promote the HEALTH project and we will begin to create a new logo. A plan for Governor's Project week will also be organized. We discussed asking clubs to add detailed descriptions in their pride reports pertaining to their Governor's Project hours to ensure that the hours fit the Governor's Project criteria.

Kiwanis Family Relations Committee Report (Chair: Ahmad Hamid)

The Kiwanis Family Relations Committee will make a survey to be completed by each Lieutenant Governor asking them to rate and describe their respective division's relations with each branch of the Kiwanis Family. We will use this data and give personal suggestions to each of them based off of their demonstrated needs. Our work will be completed by working closely with members of Kiwanis, Circle K, and the District Administrators for Builders Club and K-Kids; along with keeping constant communication with members of the Membership Development Committee. One resource we plan to offer Key Clubbers in the district are materials and documents to be placed in the Sunshine Source. We will be creating rough drafts

and articles to be put in throughout the year. The articles will cover examples of and ideas on how to involve Kiwanis/Aktion Club/Circle K/Builders Clubs/K-Kids in Key Club events along with resources. Our committee will also be working to update and maintain the most accurate record of the different clubs broken down by division, and updating a color-coded list of strongest to weakest relations between the Key Club level and the other branches. We have also set the dates for our committee conference calls and will be creating a timeline to help us delegate our work.

Legal, Elections, and Credentials Committee Report (Chair: Vanessa Paneque)

Before the August Board Meeting, my committee will review and revise all the candidate forms to ensure that they are accessible and concise. We will do this by creating a Committee Google Drive to update these forms and work with the District Webmaster. The changes to these forms include board meeting dates, training dates, the Annual District Conference dates, and candidate form due dates. The committee will also read through the Florida District Bylaws and document any changes to be discussed with the District Board which will be made closer to the January Board Meeting. We will create a timeline of goals and due dates until the District Conference so we will be organized for upcoming elections, and Spring Zone Rally dates. In addition, we will be using Google docs and excel to check off candidate information and update results as we approach the winter board meeting.

Marketing Committee Report (Chair: Bailey Campbell)

Before August Board the Marketing committee will determine what system they will use to create graphics and flyers to distribute to LTGs for their MEBs. We will choose a common theme for each month's graphic that gets distributed; this theme will reflect the values of Key Club International, while grabbing members' attention. Prospective ideas for obtaining an audience include the use of #BeTheKey pictures, photo montages, encouraging videos, and ideas for scavenger hunts that LTGs can incorporate into their MEBs. The committee also plans to create a schedule of topics to include in monthly graphics and flyers. For the month of July the topic will focus on summer service, and for the months during the beginning of the school year, the topic will shift to discuss acquiring membership and submitting dues. These graphics and flyers will be completed and distributed by the 25th of each month.

Membership Development Committee Report (Chair: Gustavo Fernandez)

After reviewing the Membership Development Committee objectives, as a committee, we talked about the issues concerning the membership numbers in our Mighty Mighty Florida District of Key Club International. As a committee, we want to increase our total number of members by increasing club growth throughout the division. We discussed issues with the smaller clubs in our district and talked about different types of issues they may face. As a committee, we discussed the different resources we can offer for our officers to grow their clubs during the beginning of the school year by offering them different resources during the summer months. We discussed different way of distributing the information to the officers by either including information in LTGs MEBs or by sending mass emails to club presidents and secretaries. We also talked about the issues concerning clubs with the smaller membership. We will start

creating a timeline this week to expedite all the resources during the summer months so we have less work during the school year. Also, we want to have the resources available by the beginning of the school year because we want to be able to distribute the resources for the beginning of the school year as well as KCKC. As a committee chair I plan on delegating different things to different members of the committee with due dates during the summer months.

Public Relations Committee Report (Chair: Sohayla Eldeeb)

During our June Board Meeting that took place on Friday night (June 9th, 2017), we discussed multiple key points for our committee and clarified the purpose that will bind our committee. Most importantly, we got to know each other as our own leaders and focused on everyone's own approach to public relations. Moving forward, we will discuss and review an example of a pressrelease that will be found on the Florida Key Club Website which will enable each club to promote their progress. In addition, we will organize a "tip list" on how clubs may use their press-release with specific target audiences and where clubs may find their sample target audiences. The committee will also create a helpful document on the importance of collaborating with other groups such as SGA and events during school that will in turn will allow clubs to earn a free opportunity for their efforts to get recognized. We will also plan ahead to work with the executive committee to update on the YouTube channel on a scheduled basis, because of YouTube's vital role in both entertaining and informing Key Clubbers. In addition to the executive committee, we will work with the Scholarships Committee in helping them promote their purpose in an entertaining video. We aim to achieve this before August. As a committee, we wish to publish our own YouTube videos that won't be on a scheduled basis however they will be liable to any club wishing to seek advice on what Public Relations is and how crucial it is. Finally, a sense of communication that we wish to achieve within our committee will be achieved through conference calls scheduled for Saturday mornings.

Scholarships Committee Report (Chair: Robin Moscovitch)

For the Scholarship committee, we have decided before the August board meeting, we are going to start finding people to judge scholarships. We plan to start working with the Kiwanis Family (Key Club LTGs, CKI, Kiwanis) to assist with judging scholarships. The applications will be judged by the people who live in different parts of the district, so there will be no conflict of interest. (North Florida applicants will judge South Florida etc...) We have planned to create a step-by-step video on how to fill out the basic scholarship application. We have decided that we will ask all LTG to put a hyperlink in their M.E.B. with a link to the scholarship page on the key club website when we get closer to the deadline. We hope to work with the Public Relations Committee about making a video to show at KCKC and SZR to increase applicant yield for scholarships. This concludes my committee report.

Service & Major Emphasis Committee Report (Chair: Lisa Dong)

Before August Board, my committee and I plan to review, revise, and update the Service booklet on the Florida Key Club website. The following members will be covering the different sections of the booklet as listed below. All pages will be submitted to the Chair for review by July 28th, 2017 at 11:59pm and all changes will be finalized by August 9th, 2017 at 11:59pm. For those residing in the Panhandle and the Cayman Islands, the conference will be at 8am since they are one hour behind. In the meantime, I will be communicating with the members regarding workshop topics and then relating those to the Education Committee. The booklet will continue to educate clubs about Service and Major Emphasis Partners and other ideas as we emphasize our page on the Florida Key Club website. In addition, many examples will be highlighted in each section to help inspire ideas and we will promote the importance of educating clubs about the definition of a service hour.

Trick-or-Treat for UNICEF Committee (Chair: Jessica Ferrante)

Before the August Board, this committee plans to develop and explore advertising and fundraising ideas directed towards the Trick-or-Treat for UNICEF organization. So far, we have discussed ideas including division-wide activities, including Trick-or-Treat for UNICEF in the MEB topic list throughout the fall months, and considering product fundraising methods. The first thing our committee discussed was to figure out how clubs could retrieve the UNICEF Trick-or-Treat boxes in a simple and efficient way. Our committee will speak with the executive editor to involve the UNICEF Trick-or-Treat boxes in the Monthly Electronic Bulletin (MEB). This will promote the advertisement of the organization. The committee came up with the idea to pull funds from the Florida District Endowment fund. However, this has become an unreachable goal, because the organization would prefer that the monies raised for the organization are fundraised through the UNICEF name to promote the charity itself. The committee also discussed division wide activities, including activities similar to Dance Marathon, where there is an entrance fee or tickets are purchased and donated towards the funds.
