#### Kiwanis Family Relations:

The first one is the September edition and it covers Governor Allen Whetsell, Kiwanis DCON, The Eliminate Project, as well as what are goals are as a committee. The second edition was released in October and it covers what is CKI, CKI Governor Sara Fruithandler, and CKI's district goals for this year. The third edition was published in December and it highlights Key Club, our Executive Committee, and the accomplishments our District has made thus far.
- We have also created a Kiwanis Family video. Its purpose is to showcase the amazing Kiwanis Family spirit our district has as well as to encourage and inspire Key Clubbers to connect with the various branches of the Kiwanis Family. Show video now.
- We have also advertised the Robert W. Thal Outstanding Kiwanis Sponsor Award, but due to a late advertising on my part we were only able to receive one application.

What we plan to continue with in the future:

My committee has added a complete list of the giving totals for each club in the Florida district. Each club can now visit the Florida key club website and review the amount they have donated towards The Eliminate project within the last two years. This will help clubs track their progress and set goals for the years to come. As some of you may know Kiwanis has challenged their SLPs to raise \$5.40 per member within this Kiwanis year. That puts the Florida District in a position to reach over a hundred thousand in less than a year. As you all have seen, my committee has reached out to each zone to encourage zone wide fundraisers. Thank you to all the divisions & zones that have begun planning fundraisers for their area, you are setting a great example to your clubs. We've also just completed our second order of 600 sunglasses which brings our total profit with both orders to \$10,400. We've also began Eliminate Project video contests which serve as fundraisers for the project as well as a promotional tool. Club or individuals can enter a promotional video for the cost of a \$20 donation to The Eliminate Project. Video will be judged by my entire committee and the winner will be presented with an award and special recognition at DCON. The contest rules are available online.

#### DCON:

It was announced that Josh Sundquist would be the Keynote Speaker for the 2013 District Education and Leadership Conference. Josh is a paralympian, cancer survivor, and a best-selling author. A video was shown in which expressed his enthusiasm, showed how he tells his life story with vigor and showcased message that will be perfect for our conference.

The committee said they had been mainly working on getting out promotional items to the district, creating resources, and finishing all aspects of the online registration. These resources include items such as the DCON Fundraising Guide, DCON Fact Sheet, etc. Promotional items include the DCON Postcard, the monthly blurbs, emails to the District and getting the DCON webpage up to date. Other finer details such as the schedules for DCON are being finalized to have ready for the conference.

Another goal that the committee has been working towards is harnessing sponsorships. The sponsorship packet was created and the committee reached out to dozens of different companies asking for their support. They reported that they had received a couple replies and that they were in the works of being finalized.

All in all, the committee has completed it directives and will be working very hard in the next few months to make the 75<sup>th</sup> Annual District Education and Leadership Conference a success.

Florida. An additional condensed format of the guidebook as a flyer was created and presented with the guidebook. The committee created a checklist resource for lieutenant governors to use during the focus month of February for the Home Project about promoting the Governor's Project and organizing divisional and club projects with the best quality and quantity.

#### Club Growth:

Over the past few months our committee has built the club growth page on the district website with the help of Jesus. You can see various resources posted on the page. Some of you may remember the problems and solutions guide we were working on at last board meeting and it is still in the works. I plan to post the smaller documents that contributed to the current guide on the website until the full document is completed. We have been attempting to do weekly conference calls and have been having some issues with them. They will begin again in the third week of January and we hope to have most of the kinks worked out at that point and hope that all of you will get involved with some of the calls. Ahmed is currently working on building a Club Chartering Page for the district website by expanding on Key Club Internationals existing page and documents. Starting in two weeks we will be using Kristen's excel dues reports to target clubs with less than 20 members. I will likely send emails to these Lt. Governors specifically. It is very helpful for me if when you see a club struggling with membership you contact me to discuss it either by email or by phone. Many Lt. Governors have already done this and with the new dues reports I hope to see more. The weekly calls are also a great place to get ideas to help struggling clubs.

At the 75<sup>th</sup> annual conference, these carried on trophies will officially retire and will be stored at the District office. For Key Club of the Year, and G. Harold Martin Outstanding Club President Finalists, certificates will be given to help recognize the outstanding work of each of these individuals and clubs. Patch designs for the Kiwanis Family Ties Patch will remain the same. Key Club Early Bird Due Patch and UNICEF/Eliminate Patch will be given by international. Governor's Project Patch will be using the Governor's project logo created by Michaela that is also previewed in the Governor's Project booklet. Pre-DCON judging will take place in two different ways. Distinguished Officer/Member awards will be distributed throughout the Awards DCON sub-committee and electronically. All applications will be reviewed for accurate recording of points. Close to Award deadline time, we will be meeting in Tampa for judging of awards that require applications, but are not distinguished officer/members. Seniors will be pulled from the surrounding divisions in Zone E to judge awards that need to be judged, but no judge will judge an award that their home club has submitted. While Pre-DCON judging, signatures will be verified to ensure approval of faculty advisors and presidents. Any other judging, including contests, will be judged at District Conference. Awards, such as the Pride Report Submission award, early bird dues, eliminate/UNICEF fundraising will be judged with information provided by our District Secretary and Key Club International. At conference, we will be having a host club to help run errands at the conference. Encourage clubs to apply for awards; deadline is March 5<sup>th</sup> for all awards and contests, but Outstanding Faculty and Kiwanis Advisor portfolios are due February 28th.

Division 14C Lt. Governor Freddy Jimenez moved to have the Jack Gander Outstanding Faculty Advisor, J. Walker Field Outstanding Kiwanis Advisor and the Every Child a Swimmer award from trophies to plaques. Division 19 Lt. Governor Rashon Murph seconded and there was discussion about this motion. Division 20 Lt. Governor Shane Meyers moved to limit discussion time to 10minutes. Division 5 Lt. Governor Austin Eckels seconded and the motion carried. Division 8 Lt. Governor Danielle Burris moved to amend the proposal by having the trophies retire. Division 5 Lt Governor Austin Eckels seconded. Motion carried. The final amended proposal was then voted open and carried.

#### Talent:

The talent and productions committee is basically in charge of the talent and oratorical contests as well as the music, videos, and slideshows of the general sessions. As you know, we just recorded the video that will be played at the very beginning of opening session in which the entire district board passes on a torch and will end with Governor Sam running into the opening session and starting our District Conference. I wanted to thank all of you for participating and being so cooperative in helping us create this video. Our committee discussed promotion of the talent and oratorical contests and that it is the Lieutenant Governor's responsibility to contact their clubs and remind them that there are talent and oratorical contests; in which this years' oratorical contest topic is: How do people know you're a Key Clubber? Our committee will be providing a monthly blurb which will be made and then approved by the rest of our committee before being sent out to the entire board. Our committee would like to encourage all of you to promote the talent and oratorical contests at the DCON presentation during your Spring Zones Rallies. Our committee is also responsible for the board slideshow/video that will be played during the Governor's Banquet. For this, we are going to need as many pictures as possible, so please take a lot of pictures this weekend and at your Spring Zone Rallies with your fellow board members. I will be sending out an email after this weekend to remind you all to send me those pictures. Lastly, we discussed music for the dances and sessions in which there is a list from previous years that we will be obtaining from DCON Chair Amanda Hernandez and we are looking for music suggestions from you. Please remember that this music must be appropriate, but that does not mean that it must be boring. I know many of you went to the neon dance at ICON in which there was appropriate music played, but attendees did actually have fun. We felt that a vibe such as that would be more appealing to both the attendees and the adults and chaperones. Therefore, our committee feels that a "meaningful service" is best defined as follows: Meaningful and impact projects meet a community need, provide significant learning experiences and opportunities, and reinforce the fact that the world is diverse and requires each of our unique skills to thrive. Such projects touch not only our lives, but the lives of others in ways that improve a situation, supports a cause, or raises awareness thereby making a significant impact on us and others.

#### Schedule:

#### Thursday:

Members arrive between 4 and 6 p.m. Review schedule for the weekend. Dinner at Days Inn (food from outside source).

#### Friday:

Breakfast at Days Inn (included in room rate).

Volunteer on project site from 8 a.m.-2 p.m.

Lunch provided by Habitat for Humanity.

Volunteer at food bank/other organization later in afternoon.

Dinner at Days Inn (food from outside source).

#### Saturday:

Breakfast at Days Inn (included in room rate).

Volunteer on project site from 8 a.m.-2 p.m.

Lunch provided by Habitat for Humanity.

Return to Days Inn to collect suitcases. Members leave by 4 p.m.

#### **Details of Project:**

To support the Governor's Project, called the Home Project, up to 40 members of the Florida District will gather in Winter Haven to work on a project site for Habitat for Humanity of East Polk County.

Habitat for Humanity is currently developing a site in Winter Haven that will have six houses on it. This might be available for us to work on in March. If not, we will work on two separate sites.

Volunteers under the age of 18 cannot do some of the construction, but they can paint, help with landscaping, etc. The volunteer coordinator at Habitat for Humanity of East Polk County said that there will be plenty for everyone to do.

Friday afternoon, after working with Habitat for Humanity, we will volunteer at a food bank or at another organization that serves the homeless population.

#### **Traveling Policy:**

Adults must drive Key Club members to the Days Inn on Thursday and from the Days Inn on Saturday. During the service trip members will be transported by passenger vans that chaperones will drive, if adult transportation is not available to a member through previously made arrangements. Two 10 passenger vans will be available to those unable to receive transportation on their own by an adult.

#### **Chaperones:**

There will be at least one chaperone for every 10 youth.





Dear David:

IRS has a requirement regarding conflict of interest that may arise in a tax-exempt organization. It is specifically for those instances where an officer or director might benefit from a business transaction made by the organization's Board of Directors. It only applies to those transactions where an officer or director would be in a position to cast a vote on a transaction that benefits that specific officer or director.

If your Organization is dealing with a business transaction, (for example, the purchase of office equipment) that would benefit one of the Directors who is present when the vote is taken on that specific issue; then that person should not vote on the issue. It is permissible for that person to offer opinion or other information, but should not vote.

In this example, there is <u>only</u> a conflict of interest if the Board first decides that a conflict of interest exists. This is an important distinction: there is no conflict of interest if the Board first declares that none exists.

IRS has provided "Appendix A: Sample Conflict of Interest Policy" which contains appropriate wording for such a policy. At it's next BOD meeting, your Organization should pass a motion to adopt the procedure as specified in the attached sample. The motion should include a provision that Appendix A be a part of the minutes. The procedure would then be used only if the BOD first decides a conflict of interest exists.

Please provide me with a copy of the minutes of your BOD meeting where this action was approved: I need to have proof that this was done should IRS make an inquiry regarding your Foundation's tax exempt status.

Title: Conflict of Interest Policy
Scope
This document contains the IRS required policy for a $501(c)(3)$ organization and describes how the organization will handle situations where an officer or director would be in a position to cast a vote on a transaction that benefits that specific officer or director.

#### Conflict of Interest Policy

#### Article I Purpose

The purpose of the conflict of interest policy is to protect this tax-exempt organization's interest (Organization) when it is contemplating entering into a transaction or arrangement that might benefit the private interest of an officer or director of the Organization or might result in a possible excess benefit transaction. This policy is intended to supplement but not replace any applicable state and federal laws governing conflict of Interest applicable to nonprofit and charitable organizations.

#### Article II Definitions

#### 1. Interested Person

Any director, principal officer, Or member of a committee with governing board delegated powers, who has a direct or indirect financial interest, as defined below, is an interested person.

#### 2. Financial Interest

A person has a financial interest if the person has, directly or indirectly, through business, investment, or family:

- a. An ownership or investment interest in any entity with which the Organization has a transaction or arrangement,
- b. A compensation arrangement with the Organization or with any entity or individual with which the Organization has a transaction or arrangement, or
- c. A potential ownership or investment interest in, or compensation arrangement with, any entity or individual with which the Organization is negotiating a transaction or arrangement.

Compensation includes direct and indirect remuneration as well as gifts or favors that are not insubstantial.

A financial interest is not necessarily a conflict of interest. Under Article III, Section 2, a person who has a financial interest may have a conflict of interest only if the appropriate governing board or committee decides that a conflict of interest exists.

#### Article III Procedures

#### 1. Duty to Disclose

In connection with any actual or possible conflict of interest, an interested person must disclose the existence of the financial interest and be given the opportunity to disclose all material facts to the directors and members of committees with governing board delegated powers considering the proposed transaction or arrangement.

#### 2. Determining Whether a Conflict of Interest Exists

After disclosure of the financial interest and all material facts, and after any discussion with the interested person, he/she shall leave the governing board or committee meeting while the determination of a conflict of interest is discussed and voted upon. The remaining board or committee members shall decide if a conflict of interest exists.

3. Procedures for Addressing the Conflict of Interest

- a. An interested person may make a presentation at the governing board or committee meeting, but after the presentation, he/she shall leave the meeting during the discussion of, and the vote on, the transaction or arrangement involving the possible conflict of interest.
- b. The chairperson of the governing board or committee shall, if appropriate, appoint a disinterested person or committee to investigate alternatives to the proposed transaction or arrangement.
- c. After exercising due diligence, the governing board or committee shall determine whether the Organization can obtain with reasonable efforts a more advantageous transaction or arrangement from a person or entity that would not give rise to a conflict of interest.
- d. If a more advantageous transaction or arrangement is not reasonably possible under circumstances not producing a conflict of interest, the governing board or committee shall determine by a majority vote of the disinterested directors whether the transaction or arrangement is in the Organization's best interest, for its own benefit, and whether it is fair and reasonable. In conformity with the above determination it shall make its decision as to whether to enter into the transaction or arrangement.
- 4. Violations of the Conflicts of Interest Policy
  - a. If the governing board or committee has reasonable cause to believe a member has failed to disclose actual or possible conflicts of interest, it shall inform the member or the basis for such belief and afford the member an opportunity to explain the alleged failure to disclose.
  - b. If, after hearing the member's response and after making further investigation as warranted by the circumstances, the governing board or committee determines the member has failed to disclose an actual or possible conflict of interest, it shall take appropriate disciplinary and corrective action.

# Article IV Records of Proceedings

The minutes of the governing board and all committees with board delegated powers shall contain:

- a. The names of the persons who disclosed or otherwise were found to have a financial interest in connection with an actual or possible conflict of interest, the nature of the financial interest, any action taken to determine whether a conflict of interest was present, and the governing board's or committee's decision as to whether a conflict of interest in fact existed.
- b. The names of the persons who were present for discussions and votes relating to the transaction or arrangement, the content of the discussion, including any alternatives to the proposed transaction or arrangement, and a record of any votes taken in connection with the proceedings.

#### Article V Compensation

- A voting member of the governing board who receives compensation, directly or indirectly, from the Organization for services is precluded from voting on matters pertaining to that member's compensation.
- b. A voting member of any committee whose jurisdiction includes compensation matters and who receives compensation, directly or indirectly, from the Organization for services is precluded from voting on matters pertaining to that member's compensation.
- c. No voting member of the governing board or any committee whose jurisdiction includes compensation matters and who receives compensation, directly or indirectly, from the Organization, either individually or *collectively*, is prohibited from providing information to any committee regarding compensation.

#### Article VI Annual Statements

Each director, principal officer and member of a committee with governing board delegated powers shall annually sign a statement which affirms such person:

- a. Has received a copy of the conflicts of interest policy,
- b. Has read and understands the policy,

- c. Has agreed to comply with the policy, and
- d. Understands the Organization is charitable and in order to maintain its federal tax exemption it must engage primarily in activities which accomplish one or more of its tax-exempt purposes.

#### Article VII Periodic Reviews

To ensure the Organization operates in a manner consistent with charitable purposes and does not engage in activities that could jeopardize its lax-exempt status, periodic reviews shall be conducted. The periodic reviews shall, at a minimum, include the following subjects:

- a. Whether compensation arrangements and benefits are reasonable, based on competent survey information, and the result of arm's length bargaining.
- b. Whether partnerships, joint ventures, and arrangements with management organizations conform to the Organization's written policies, are properly recorded, reflect reasonable investment or payments for goods and services, further charitable purposes and do not result in inurnment, impermissible private benefit or in an excess benefit transaction.

# Article VIII Use of Outside Experts

When conducting the periodic reviews as provided for in Article VII, the Organization may, but need not, use outside advisors. If outside experts are used, their use shall not relieve the governing board of its responsibility for ensuring periodic reviews are conducted.
